The arthritis community is a significant constituency in Saskatchewan.

In the lead up to the provincial election, Arthritis Consumer Experts (ACE) is asking Saskatchewan's political leaders to share their plan on how to meet the needs of more than 160,000 Saskatchewan residents living with arthritis.

The Saskatchewan Party has stated, if re-elected, it will look for ways to innovate and improve health care, including:

- Reducing administrative positions and costs in Regional Health Authorities by \$7.5 million, with savings allocated towards front line care in long-term care facilities;
- Providing \$500,000 in annual funding to the Canadian National Institute for the Blind to integrate vision loss rehabilitation services into the mainstream health system;
- Reducing CT scan wait lists by providing patients with the option to pay privately for CT scans using the
 "two-for-one" model recently introduced for MRI scans, under which for every scan paid for privately,
 the clinic must provide one scan at no charge to a patient on the public list; and
- Providing an additional \$500,000 annually to expand the remote presence technology pilot project underway in Pelican Narrows to other communities.
